# STATEMENT REGARDING THE ACCESSIBILITY OF THE WEBSITE PURSUANT TO ITALIAN LEGISLATIVE DECREE NO. 82/2022

# (IMPLEMENTATION OF EU DIRECTIVE 2019/882)

#### **COMPLIANCE STATUS**
